210. Matters Relating to Street Furniture/Amenity Provision

- (a) Report on Speed Indicator Device Findings Results remain consistent. However, there were one or two incidents where very high speeds on Hurdle Drove and Pott Hall Road were noted.
- (b) Update on Footpath 30 (eroded riverbank) along river at bottom of The Gravel Nothing to report.
- (c) SCC Development –Cllr M Peachey has spoken with Lovells who advise that due to various consultee feedback, they are having to amend their plans. They are having to make amendments to satisfy SCC Highways and the bin collections team. Once a revised plan has been finalised, they will share with WRPC.
- (d) Update on Storage Facility After checking out the container at the Village Hall, we found the container was not suitable for our needs. The Bowls Club have offered the use of the old club pavilion for our storage and monthly meetings at a cost of £1,500.00 per year. Council approved and supported. Awaiting further feedback from the Bowls Club.
- (e) Blue Plaques Close.
- (f) Shop Drove Footpath Ongoing.
- (g) Building site at the entrance to Pott Hall Road See above report from D/Cllr D Waldron.
- (h) New Cemetery WRPC are required to submit some further information to WSC on a few points for their approval. Cllr M Peachey has received the Biodiversity Enhancement Strategy from our Ecologist, which has enabled him to start work on the planting plans. The

information regarding the proposed gates has been compiled. Regarding the archaeological conditions, Cllr M Peachey reached out to 5 companies, 4 of which provided quotes. The best quote was accepted, and a draft Written Scheme of Investigation has been produced and sent to SCC Archaeology for their review. (This is the plan of how they are going to do the archaeological dig/survey.) Cllr M Peachey is hoping that an application to WSC requesting the discharge of the conditions for all these points can be submitted by the end of the month. We are still awaiting further guidance from SCC regarding the land transfer; however, Cllr M Peachey has chased them up.

- (i) Community Assets Village Hall, Bowls Club & Amenities. WRVHF have agreed to proceed with the village hall becoming a community asset. Awaiting paperwork from WRVHF.
- (j) Additional defibrillators at the end of Eldo Road, and one by the Coffee shop. Ongoing.
- (k) Bridleway to Mildenhall. Wamil Hall path wording. Ongoing.
- (I) Streetlight Electricity Supplier Changeover. Quotation finally received from SSE which was a lot cheaper than our current supplier. Council approved and supported to change supplier.
- (m) Banners for Notice Board opposite Plantation Farm Ongoing.

211. Other Working Party Updates/Reports

- (a) Update on the Echo/Parish Magazine Magazine going to print.
- (b) Update on Neighbourhood Plan Cllr M Peachey reviewed the Draft Green Spaces report and provided some feedback to Ian Poole. Some of the areas identified did not meet the required standards for inclusion, a few more were questionable, and Ian Poole is awaiting further guidance himself based on another plan he is working on. Several spaces are suitable though and overall, Cllr M Peachey was content with the report which will be incorporated into the draft plan. We are now waiting on the Key Views report.

- (d) 100 Club Update Draw has taken place, and the winning number was 144 Liz & John Walter.
